## MINUTES OF THE REGULAR MEETING OF THE SUPERVISORS OF HEIDELBERG TOWNSHIP, BERKS COUNTY HELD AUGUST 29, 2019

<u>PRESENT:</u> David Randler, Thomas Schoener, Terry Wolfe, David Manbeck, Brian Thumm, Carol and Bob Keppley, EmmaRose Boyle, Randy Gartner, David Kostival, Mark Wagner, Brenda Wagner, Logan Sensenig, Michele Davis, Dean Sensenig, Kevin Snyder, Sean McKee, Jim Dotzenroth, Leon Grim, John T. Adams, Craig Lutz and Cheryl Bowers.

The meeting was called to order by Chairman Randler at 7:30 PM with the Pledge of Allegiance.

### **AUDIENCE PARTICIPATION**

**LOGAN SENSENIG** – Mr. Sensing purchased the George Merkel property on Matthews Drive. Mr. Sensenig presented a description of the property and a sketch plan that was prepared 10/29/92, however it was never reviewed by the Township or recorded. After some discussion, Mr. Sensing was told he must go through an annexation process to correct the problem.

At this time Chairman Randler read a statement pertaining to joining South Heidelberg Township Police. A copy of the statement is attached.

Supv. Wolfe asked Chairman Randler why the Heidelberg Township Police Committee wasn't notified of the proposal and asked if he was acting on his own. Chairman Randler stated he knew that Wernersville and Robesonia are going with South Heidelberg and thought it was an important topic, we can get better coverage. Supv. Wolfe asked if the SRO would be staying.

Chairman Randler stated that the Mom & Pop police forces are a thing of the past and the proposal from South Heidelberg would include 40 hours of coverage each week with 24/7 emergency coverage. This would be a win for residents of Heidelberg Township since we currently have to depend on State Police coverage when our officers are not on duty.

Supv. Schoener said he only found out of the proposal at 12:18 PM today and it would have been nice to have been prepared.

#### **SEAN MCKEE**

JOHN ADAMS, DA —Sean McKee, South Heidelberg Township Manager introduced DA John Adams. Mr. Adams stated he is in support of regional police. There are 37 police departments in the County and he has supported regionalization for years. He stated he is looking for efficiency in police departments. This means that someone is on patrol 24/7 and that's not possible in Heidelberg Township. Chief Stone can't do it by himself — he needs back-up. Also, the Conrad Weiser School and Bethany Children's home are in Heidelberg Township and they aren't going anywhere. This proposal would be a benefit to the County and the residents of Heidelberg Township.

Supv. Wolfe asked about the cost. A proposal was circulated by Sean McKee.

Randy Gartner, Mayor of Robesonia said going with S. Heidelberg will save Robesonia \$70,000 the first year. The police get to know the people and businesses and they want to know what the municipalities want. Sean McKee said communication is important and there is value in regional services – officer safety with a full department to back each other up. This is a service South Heidelberg Township would provide. They have a commitment to service – Heidelberg is the customer. They modeled it after Northern York Regional and Chief Benzel of Northern York would be happy to sit down with Heidelberg

to discuss anything. Chief Benzel has been a resource for Chief Grimm (South Heidelberg police chief). Sean also stated there is value in having the ability to have a full department for all the municipalities. They are offering the same proposal they gave to Wernersville and Robesonia. The geographical area is a win for all.

Supv. Schoener said we are now getting 96 hours of coverage. Chairman Randler said if we go with South Heidelberg Township we will be getting 40 hours of "boots on the ground".

Supv. Thumm asked if there is any state funding. Chief Grimm said contracting services does not quality, however with Chief Stone coming on board it might help qualify for a grant.

Discussion on the SRO. They currently have 2 officers scheduled for training and by the end of September will be qualified. Supv. Wolfe said "so you will be getting rid of the current SRO"? Chairman Randler said that he was against the way the SRO program was put together last year.

Supv. Wolfe asked what the hurry is, the community doesn't know anything about this proposal, and why is everything being kept secret.

Chairman Randler made a motion to proceed with the proposal from South Heidelberg Township to contract services for police coverage. The motion died for lack of a second motion.

Kevin Snyder asked if it would take an Ordinance to disband the Heidelberg Police Department. After much discussion, Supv. Schoener made a motion to table the proposal till the September 26<sup>th</sup> regular scheduled Supervisors meeting. Motion seconded by Supv. Wolfe and passed unanimously.

<u>MINUTES:</u> The minutes of the July 25, 2019 meeting were circulated. Supv. Manbeck made a motion to approve the July 25, 2019 minutes as circulated, seconded by Supv. Schoener and passed unanimously.

**TREASURERS REPORT:** Treasurer Carol Keppley circulated the August treasurers report. Chairman Randler made a motion to approve the August treasurers report, seconded by Supv. Manbeck and passed unanimously.

<u>PAYMENT OF BILLS:</u> Treasurer Carol Keppley presented the bills for payment. Supv. Manbeck made a motion to pay the bills as presented, seconded by Supv. Wolfe and passed unanimously.

### **COMMITTEE REPORTS**

SEWER – Chairman Randler reported Ditchcreek has not called back regarding the control panel and videoing lines on Jackie & Lynn. Discussion on Harold Mogel. Supv. Thumm stated the Board should vote on issues like this. Chairman Randler asked how we got to the balance of \$3,000.00 when it should have been an issue when he owed \$500.00. Carol stated there is already a lien on Mr. Mogel's property. After more discussion it was decided that Carol should send the letter to Mr. Mogel for his signature and he will agree to pay \$100 each month or more.

Courtney Keller at 105 N. Freeman St. – she is having back-up problems and her plumber can't find laterals, nor could Larry Knoll. Chairman Randler stated that we might need to contact Ditchcreek to come in and video the lines.

Resident of Jackie Ave. inquired about fixing the curbs and cold patching the sinking macadam.

POLICE & FIRE - The police report and September schedule were circulated. Supv. Manbeck made a motion to approve the September schedule, seconded by Supv. Schoener and passed unanimously.
