ORDINANCE NO. 2021 -01 BOROUGH OF WOMELSDORF BERKS COUNTY, PENNSYLVANIA

AN ORDINANCE OF NORTH HEIDELBERG TOWNSHIP, HEIDELBERG TOWNSHIP, THE BOROUGH OF ROBESONIA, AND THE BOROUGH OF WOMELSDORF, BERKS COUNTY, PENNSYLVANIA: TO AMEND THEIR JOINT ZONING ORDINANCE, AS AMENDED, REPEALING AND REENACTING SECTIONS 402.H.5 and 402.I.5 REGARDING THE PARKING OF JUNK VEHICLES.

WHEREAS, "junk vehicles" as defined in Article 2, pose a risk to the public health, safety and welfare.

NOW THEREFORE, BE IT ENACTED AND ORDAINED by the governing bodies of the Municipalities, and it is hereby enacted and ordained by the authority of the same as follows:

SECTION 1. Section 402.H.5 of the Joint Zoning Ordinance is hereby repealed in its entirety and restated as follows:

- a) In North Heidelberg Township, Womelsdorf Borough, and Marion Township, when Marion Township becomes a participating member of the Joint Zoning Ordinance, the following regulations shall apply: Any "junk vehicle" (as defined by Article 2) shall not be stored for more than 20 days within view of a public street or dwelling. A maximum of 6 junk vehicles may be parked on a lot outside of an enclosed building at any one time. Any junk vehicle stored outside overnight shall be screened from view of adjacent dwellings.
- b) In Heidelberg Township and the Borough of Robesonia, the following regulations shall apply: No more than two (2) "junk vehicle" (as defined by Article 2) shall be permitted to be parked in view of a public street or residence at any time.

- SECTION 2. Section 402.I.5 of the Joint Zoning Ordinance is hereby repealed in its entirety and restated as follows:
 - a) In North Heidelberg Township, Womelsdorf Borough, and Marion Township, when Marion Township becomes a participating member of the Joint Zoning Ordinance, the following regulations shall apply: Any "junk vehicle" (as defined by Article 2) shall not be stored more than 20 days within view of a public street or dwelling. No junk vehicles shall be stored within 20 feet of an existing street right-of-way. No more than 6 junk vehicles shall be stored on the lot outside of an enclosed building at any point in time.
 - b) In Heidelberg Township and the Borough of Robesonia, the following regulations shall apply: No more than two (2) "junk vehicle" (as defined by Article 2) shall be permitted to be parked in view of a public street or residence at any time.
- SECTION 3. All other sections, parts and provisions of the Zoning Ordinance shall remain in full force and effect as previously enacted and amended.
- SECTION 4. In the event any provision, section, sentence, clause, or part of this Ordinance shall be held to be invalid, illegal, or unconstitutional by a court of competent jurisdiction, such invalidity, illegality, or unconstitutionality shall not affect or impair the remaining provisions, sections, sentences, clauses, or parts of this Ordinance, it being the intent of the Board that the remainder of the Ordinance shall be and shall remain in full force and effect.

SECTION 5. This Ordinance shall take effect and be in force from its enactment as provided by law.
